## Now is the time to invest in your career!

To qualify for a Real Estate Broker license, you are required to complete eight courses and pass the state Broker licensing exam. - Effective January 1, 2013, applicants must have at least two years of licensure as a full-time real estate salesperson during the five years immediately preceding the date of your broker examination application or obtained a bachelor's degree from a four-year college with a major or minor in real estate
